It seems like there are always "problems" at Industrial Stormwater facilities that are required to develop a Stormwater Pollution Prevention Plan (SWPPP). Some of these nagging issues include missing components, implementation shortcomings, as well as the most common issue of not having one entirely. MDNR is actively pursuing a solution by developing and distributing a template that can be used to ensure these common findings are avoided. This process has been initiated at the Regional office level and has made progress based on significant input from all of the MDNR regions. Earthjustice calls it the clean water case of the century. The Supreme Court handed down a decision in *County of Maui v. Hawai'i Wildlife Fund*. It found that point source discharges to navigable waters through groundwater are regulated under the Clean Water Act. But wait, Missouri already regulates groundwater. So does it matter here? What's all this talk about "functional equivalents" and how do you know when you've got one? Where does the burden of proof lie?

2:35 p.m. Coronavirus Wastewater Sampling Project
COVID-19 is new, but using wastewater for tracking disease, anticipating outbreaks, and understanding extent is not. Wastewater testing has proven useful in tracking diseases such as polio and norovirus. Now MDNR, DHSS and MU are cooperating to test and evaluate sewage samples from 5 pilot wastewater treatment facilities. The data generated from sewage testing will be useful for understanding the distribution of SARS-CoV-2 in Missouri, and monitoring long-term trends for indication of reemergence.
